## Sagebrush Companies Sells LoHi City View Apartments Property to Simpson Housing

Land Deal Sets Record Price Per-Square-Foot and Per-Door Basis in Denver

Caster, Principal and Vice President of Asset Management/Development for Sagebrush Companies. "There were originally four structures on the land when we acquired it, including three homes and one office building."

"We are currently pursuing other prime development locations in LoHi to build multi-family residences, including townhomes which are in high demand and in short supply," Caster continued. "We will either take future properties to construction-ready stage and sell them, or bring in a partner for a joint venture development."
